DUST CONTROL APPLICATION – 2022 SEASON

Product Used: Magnesium Chloride

- **Application and payment must be received in our office by April 29th.**
- Specific application dates are based on when the County has prepared the roads and authorized us to begin spraying. Dates are subject to change and are impacted by weather. The first application occurs Mid-May through Mid-June. The second is approximately 60 days after the first application.
- Applicant agrees to maintain flags to mark outer limits of the area to be treated. **Flags must be in place April 29th until October 31st.** Failure to do this could result in the area being bladed. Neither the County nor Heffron Services assume any liability if your flags are not in place. If area is not marked, drivers will either center on your house or use their best judgment for location.
- Our trucks are equipped with computer equipment that allows us to spray the exact amount of footage ordered. If your flags are set longer than the footage paid for, your dust control will not reach both flags. If your flags are set shorter than the footage paid for, your dust control will extend past your flags.
- The county reserves the right to blade the treated area to maintain the public safety. Your road will be bladed after October 1st.
- Heffron Services, Inc. does not guarantee the performance of the product due to factors such as weather, surface preparation, gravel materials, heavy traffic patterns and maintenance of the roadway.
- **Include payment with this application.** We will cash your check after the first application, or May 15th whichever is earlier.

THIS PERMIT IS SUBJECT TO THE FOLLOWING CONDITIONS:

1. APPLICANT SHALL RETURN THIS APPLICATION A MINIMUM OF ONE WEEK IN ADVANCE OF THE TREATMENT IN ORDER TO GIVE THE DES MOINES COUNTY ROAD DEPARTMENT TIME TO BLADE AND SHAPE THE ROAD.
2. THE APPLICANT IS RESPONSIBLE FOR MAINTAINING A SUITABLE DRIVING SURFACE ON THE DUST TREATED SECTION OF ROAD. FAILURE TO FILL ANY POTHoles THAT DEVELOP WILL RESULT IN THE SCARIFYING AND OR BLADING OF THE AFFECTED AREA, WITHOUT NOTICE TO THE APPLICANT, TO RESTORE A SATISFACTORY AND SAFE DRIVING SURFACE.
3. APPLICANT UNDERSTANDS THAT COUNTY WILL LIKELY BLADE THE TREATED ROAD SECTION PRIOR TO SUBSEQUENT APPLICATIONS.
4. THIS AGREEMENT EXPIRES ON OCTOBER 15TH OF THE PRESENT YEAR.
5. IN SITUATIONS WHERE THE DUST CONTROL SECTION IS LESS THAN 1,200' LONG, THE LANDOWNER AND/OR PROFESSIONAL APPLICATION COMPANY SHALL ACCEPT LIABILITY DURING THE APPLICATION PROCESS. PROCEDURES SHOULD BE IMPLEMENTED TO PROVIDE FOR SAFETY OF THE TRAVELING PUBLIC AND THE SAFETY OF THE CREW WORKING IN THE ROADWAY.
6. IN SITUATIONS WHERE ONE OR MORE LANDOWNERS HAVE PRIVATELY PURCHASED DUST CONTROL AND CREATED A SECTION OF CONTINUOUS DUST CONTROL THAT IS A MINIMUM OF 1,200' LONG, THE FOLLOWING APPLIES: THE UNDERSIGNED HEREBY AGREES TO ACCEPT ANY AND ALL LIABILITY IN CONNECTION WITH THE TREATED CONDITION OF THE ROAD AND HEREBY AGREES TO INDEMNIFY DES MOINES COUNTY FOR ANY LIABILITY WHICH MIGHT OCCUR.
