DUST CONTROL APPLICATION – 2022 SEASON

Product Used: Magnesium Chloride

- **Application and payment must be received in our office by April 28th.**
- Specific application dates are based on when the County has prepared the roads and authorized us to begin spraying. Dates are subject to change and are impacted by weather. The first application occurs Mid-May through Mid-June. The second is approximately 60 days after the first application.
- Applicant agrees to maintain flags to mark outer limits of the area to be treated. **Flags must be in place April 28th until October 31st.** Failure to do this could result in the area being bladed. Neither the County nor Heffron Services assume any liability if your flags are not in place. If area is not marked, drivers will either center on your house or use their best judgment for location.
- Our trucks are equipped with computer equipment that allows us to spray the exact amount of footage ordered. If your flags are set longer than the footage paid for, your dust control will not reach both flags. If your flags are set shorter than the footage paid for, your dust control will extend past your flags.
- The county reserves the right to blade the treated area to maintain the public safety. Your road will be bladed after October 1st.
- Heffron Services, Inc. does not guarantee the performance of the product due to factors such as weather, surface preparation, gravel materials, heavy traffic patterns and maintenance of the roadway.
- **Include payment with this application.** We will cash your check after the first application, or May 15th whichever is earlier.

CONDITIONS OF PERMIT

The application and maintenance of chemicals to control dust on crushed rock surfaced roads shall be by permit only and in accordance with the following conditions:

1. Road chemicals may be applied by the owner or an approved contractor for owner.
2. The only materials approved for use on the roads are calcium chloride, magnesium chloride, and lignin sulfonate. Used motor oil is not allowed per EPA.
3. The owner shall maintain the treated area and repair any roughness that may develop.
4. The County reserves the right to rework the treated areas and maintain them as loose granular surfaces, without notice to the owner, if the owner fails to maintain the area in a condition acceptable to the County, and at no cost to the County.
5. On or about mid-October dust control locations will be bladed through in preparation for winter weather.
