

DUST CONTROL APPLICATION – 2023 SEASON

Product Used: Magnesium Chloride

- Application and payment must be received in our office by April 28th.
- Specific application dates are based on when the County has prepared the roads and authorized us to begin spraying. Dates are subject to change and are impacted by weather. The first application occurs Mid-May through Mid-June. The second is approximately 60 days after the first application.

- Applicant agrees to maintain flags to mark outer limits of the area to be treated. Flags must be in place April 28th until October 31st. Failure to do this could result in the area being bladed. Neither the County nor Heffron Services assume any liability if your flags are not in place. If area is not marked, drivers will either center on your house or use their best judgment for location.
- Our trucks are equipped with computer equipment that allows us to spray the exact amount of footage ordered. If your flags are set longer than the footage paid for, your dust control will not reach both flags. If your flags are set shorter than the footage paid for, your dust control will extend past your flags.
- The county reserves the right to blade the treated area to maintain the public safety. Your road will be bladed after October 1st.
- Heffron Services, Inc. does not guarantee the performance of the product due to factors such as weather, surface preparation, gravel materials, heavy traffic patterns and maintenance of the roadway.
- *Include payment with this application*. We will cash your check after the first application, or May 15th whichever is earlier.

This permit is subject to the following conditions:				

- 1. This application shall be submitted a minimum of three weeks in advance of treatment in order to give Jefferson County Road Department sufficient time to prepare the road surface. Applicant shall display flags at each end of the desired application area.
- 2. Only dust treatment materials approved by the County Engineer shall be used. Calcium Chloride, Magnesium Chloride, Lignin Sulfate (tree sap), Soy oil (modified for dust control), or other material from an approved source will be allowed. Applicant is responsible for hiring an approved contractor.
- 3. Applicant is responsible for maintaining a suitable driving surface on the treated section of road. Failure to fill any potholes that develop will result in the scarifying and or blading of the affected area to restore a safe and satisfactory driving surface. This may be done without notice to the applicant.
- 4. This permit expires on October 15th of the present year and roads are thereafter prepared for winter.
- 5. The undersigned agrees to accept any and all liability in connection with any accident which might result at the time of application of the dust control, or any accident which might occur at a future date as a result of the treated condition of the road, and hereby agrees to indemnify Jefferson County for any liability which might occur as a result of the treated condition of the road in consideration of Jefferson Counties' permission to the undersigned to treat said road.
