## DUST CONTROL APPLICATION – 2021 SEASON

**Product Used:** Magnesium Chloride

- **Application and payment must be received in our office by May 1<sup>st</sup>.**
- Specific application dates are based on when the County has prepared the roads and authorized us to begin spraying. Dates are subject to change and are impacted by weather. The first application occurs Mid-May through Mid-June. The second is approximately 60 days after the first application.
- Applicant agrees to maintain flags to mark outer limits of the area to be treated. **Flags must be in place May 1<sup>st</sup> until October 15<sup>th</sup>.** Failure to do this could result in the area being bladed. Neither the County nor Heffron Services assume any liability if your flags are not in place. If area is not marked, drivers will either center on your house or use their best judgment for location.
- Our trucks are equipped with computer equipment that allows us to spray the exact amount of footage ordered. If your flags are set longer than the footage paid for, your dust control will not reach both flags. If your flags are set shorter than the footage paid for, your dust control will extend past your flags.
- The county reserves the right to blade the treated area to maintain the public safety. Your road will be bladed after October 1<sup>st</sup>.
- Heffron Services, Inc. does not guarantee the performance of the product due to factors such as weather, surface preparation, gravel materials, heavy traffic patterns and maintenance of the roadway.
- **Include payment with this application.** We will cash your check after the first application, or May 15<sup>th</sup> whichever is earlier.
